Each FSPA Chapter may select a winner who will be named the FSPA Service Professional of the Year at the Everything Under the Sunsm Expo in Orlando on February 13, 2020.

How to Enter

Nominate one of your employees or a fellow pool professional by completing the entry form and send it with two letters from satisfied customers to the Florida Swimming Pool Association via fax at (941) 366-7433 or by e-mail to Valerie@FloridaPoolPro.com. You may also include information from web-based programs (Angie's List, Google, Yelp) which allow for customer reviews. This will be considered as supplemental information and cannot replace the requirement of letters from customers for the purpose of this awards program. Entries may be from co-workers or employers.

Rules

Candidates for the award must be owners or current employees of FSPA member firms. The application must be complete. Self nominations will not be accepted. Previous winners must wait three years before being considered agan. Entries without letters of support will be considered incomplete and not qualified for judging. Deadline is October 31, 2019.

Awards

- Winners will be featured on a cover of the Florida Pool Prosm newsletter in 2019 and interviewed for feature articles.
- Winners will be recognized at the 2020 Everything Under the Sunsm Expo Welcome Reception with an award. The reception is February 13, 2020 in Orlando.
- An electronic version of the winner logo / badge image will be available for display on your company website.
- Media releases will be sent to local media as well as trade press announcing the winners. A template media release will be available to winners so they may also promote their win with local media and for publishing on their website.
